COOKIE POLICY

This cookie policy has been created to provide information about the use of cookies and the choices you can make about them as part of privacy, personal data protection and processing policies.

Your cookies, which are mandatory to fulfill the functions of the site, are collected on the www.bmsgeridonusum.com.tr website and other owned websites (hereinafter referred to as the "Site") operated by BMS GERİ DÖNÜŞÜM SANAYİ VE TİCARET ANONİM ŞİRKETİ (hereinafter referred to as "Data Controller").

During your stay on the site, cookies, also called "cookies", may be placed on your browser. You can continue to use Site products without changing your cookie settings.

What is a Cookie?

Cookies consist of simple text files placed on your browser by the websites you visit; It does not contain identity and other private information. Although cookies do not contain such personal information, session information and similar data can be stored anonymously and used for recognizing you and similar services.

Cookie Types

- 1. **Cookies by Retention Period:** If it is deleted by closing the browser or device, it is a session cookie; if it is not deleted, it is a permanent cookie.

- 2. **Cookies by Purpose of Use:** The most general distinctions of cookies are as follows. The definitions of these cookies along with a much more detailed version are given in the table below.
 - Mandatory Cookies
 - o functionality cookies
 - o Performance-Analytical Cookies
 - o Advertising/Marketing Cookies
- 3. **Cookies by Party:** It is the distinction made according to the people who can access the cookies. By first party is meant the site owner; What is meant by the third party is anyone who accesses the cookie other than the site owner.
 - o First Party Cookies
 - Third Party Cookies

What Type of Cookies Are We Using?

The cookies listed below are processed on our website, and also you can find the name of the cookie processed, the purpose of processing, the recipients and the storage period are listed below. If the information for the beginning of the retention period is sent by the user (For

example, form, button click, etc.), it will start from the transaction date. If cookies are collected instantaneously (for example, at what minute of the video you left on Youtube), the times will start to run from the date of the last visit to the site.

How to manage or delete cookies?

The use of cookies allows the Website to serve better, but you can prevent the use of cookies if you wish. - 5. In the search field, type the name of the site whose cookies you want to delete. Cookies matching your search will be displayed.
- 6. Select the cookie(s) you want to delete and click the Delete selected button
- 7. Close the Cookies window by clicking the Close button. Then close the about:preferences page

Google Chrome

- 1. Open Chrome on your computer.
- 2. Click More Settings in the top right.
- 3. Click Advanced at the bottom.
- 4. Under "Privacy and security," click Content settings.
- 5. Click Cookies.
- 6. Under "All cookies and site data", search for the Website's name.
- 7. Click the "Remove" icon on the right of the site.
